

# MERCEDES CAR BONUS



## THE AGREEMENT

### Talk Fusion, Inc. Mercedes Madness Car Bonus Addendum and Acknowledgement of Responsibility

I have read the Talk Fusion, Inc. ("Talk Fusion") Mercedes Madness Car Bonus, and I acknowledge and agree that my participation in the Mercedes Madness Car Bonus requires that I satisfy the terms of this Addendum and the requirements in the Mercedes Madness Car Bonus. I specifically acknowledge and agree:

1. This Agreement is an addendum to my Talk Fusion Independent Associate Agreement. The Terms and Conditions of my Talk Fusion Independent Associate Agreement, and all documents incorporated by reference therein, shall remain in full force and effect.
2. To earn the Talk Fusion Car Bonus of \$600 USD, I must achieve and maintain Paid As rank of at least 3 Star under Talk Fusion's Compensation Plan for a four consecutive week period. I understand that I will not be eligible for the bonus in any four week consecutive week period that I do not satisfy the requirements to meet the Paid As rank of at least 3 Star. I understand that I am solely responsible for the down payment of my Mercedes vehicle.
3. The only acceptable makes and models under the Mercedes Madness Car Bonus are the Mercedes-Benz Class C and Above. The exterior color of the automobile must be Silver. The vehicle may be new or pre-owned. However, if the vehicle is pre-owned, it must be no more than four model years old at the time of purchase/lease, the odometer must show that the vehicle has less than 60,000 miles on it, and there must not be any visible damage to the vehicle other than normal wear for a vehicle of its age. Talk Fusion will not pay a Mercedes Madness Car Bonus to any Associate who purchases or leases an automobile that does not meet these criteria.
4. I may not assign or transfer my Mercedes Madness Car Bonuses to any third party. This includes, but is not limited to, transferring or assigning my Mercedes Madness Car Bonuses to any auto dealer, financing business, or lessor.
5. I may not combine my Mercedes Madness Car Bonuses with that of another Talk Fusion Associate's Mercedes Madness Car Bonuses toward the purchase or lease of a single vehicle. As a qualified Mercedes Madness Car Associate, I must purchase or lease my own vehicle and the car lease or title must be in my name or the name of the business entity under which I operate my Talk Fusion business.
6. I must remain an active Talk Fusion Associate in good standing with the Company.
7. I will remain eligible for the Talk Fusion Mercedes Madness Car Bonuses for so long as I meet the terms of this Addendum and own or lease the automobile that I acquired under the Car Bonus.
8. The contract for my new automobile is between me and the auto dealership and/or the lender or leasing company. Talk Fusion is not a co-signer, guarantor, or a party in any way to these contracts, and will not make any car, loan, or lease payments on my behalf.



9. Talk Fusion will pay the Mercedes Madness Car Bonuses to me for each four consecutive week period that I qualify. It is my responsibility to pay the auto dealer/lender or leasing company according to the terms of the contracts I execute with them.
10. I understand that if in any four consecutive week period I do not qualify for the Talk Fusion Mercedes Madness Car Bonuses, I am nevertheless responsible for making the car payment.
11. I am responsible for all taxes, insurance, maintenance and repairs on the automobile I acquire with Mercedes Madness Car Bonuses.
12. I am solely responsible for all liability related to the purchase and/or operation of the automobile I acquire with the Mercedes Madness Car Bonuses. I agree to indemnify Talk Fusion against any and all legal actions against Talk Fusion arising from or relating to my purchase, ownership, lease, and/or operation of my vehicle.
13. Talk Fusion reserves the right to cancel the Mercedes Madness Car Bonuses at any time, and is therein not responsible for the car payment.
14. I understand that I will not receive my Mercedes Madness Car Bonus of \$600 USD until I have emailed a photo of myself with my new Mercedes-Benz along with my testimonial to [support@talkfusion.com](mailto:support@talkfusion.com).
